General Information

Overview

The new 2021 – 2027 programming period introduces some **considerable changes in the financial allocation and control system of EU Funds**. The current **amendment of the 2014-2020 regulations, caused by COVID-19**, will additionally affect the Financial Management and Control System of the New Programming Period 2021-2027. Our experts will help you understand how these **novelties will affect your day-to-day work**. Moreover, this course comes exactly at the right time when you are **working on and negotiating your Operational Programmes**. What do the **new draft Regulations propose on programming, selection of priorities and indicators, and financial management of Operational Programmes**?
