

Terms and Conditions for Publication

1. Manuscript Submission and Format

- All manuscripts must be submitted in the house style in accordance with the respective journal's Author Guidelines, available on the journal's website.
- Authors guarantee that they have not submitted the same or substantially similar manuscript to other publishers simultaneously while awaiting the outcome of the review process.
- If the authors' organisation has limitations on the copyright or publication of the manuscript, these must be clearly disclosed by the authors at the time of submission.
- Authors may not post, upload, or otherwise make available their *published manuscript* on any third-party website, repository, or platform (including but not limited to SSRN, ResearchGate, Academia.edu, personal or institutional websites, or any open-access repository) except as expressly permitted below.

2. Pre-Publication Posting and Self-Archiving

- **Pre-peer review version:** Before submission and while their manuscript is under consideration for publication in a Lexxion journal, authors may post a pre-peer review version (the original submitted manuscript before any peer review or editorial changes) on third-party websites such as SSRN and ResearchGate.
- **Accepted manuscript version:** Once a manuscript has been accepted for publication but before publication, authors may not post, upload, or distribute the accepted version of the manuscript (the final peer-reviewed manuscript accepted for publication) to any third-party website, repository, or platform without the express prior written permission of Lexxion Publisher.
- **Published version:** Once a manuscript has been published in the journal, authors are responsible for **immediately removing any pre-peer review draft version from SSRN or any other location where it may have been posted.** The published version of the article may not be posted, uploaded, or made available on any third-party website, repository, or platform (including personal or institutional websites, ResearchGate, Academia.edu, or any open-access repository) without the express prior written permission of Lexxion Publisher, except as permitted under Clause 10 (Republication and Self-Archiving Rights) below.
- Authors acknowledge that unauthorised posting or distribution of any version of their manuscript or published article constitutes a breach of these Terms and Conditions and may result in withdrawal of the article from publication and/or legal action.

3. Peer Review and Publication Timeline

- All manuscripts are subject to peer review in accordance with the respective journal's Author Guidelines.

- Following acceptance, a manuscript will be considered for publication in a future issue of the journal. Publication timing depends on editorial planning, production schedules, review processes and timelines, and the need to ensure thematically balanced issues. All decisions regarding the scheduling and timing of publication are at the sole discretion of the journal's editors.
- The publication of all manuscripts remains at the sole discretion of Lexxion Publisher.
- Lexxion Publisher reserves the right to accept, reject, or remove any material submitted for publication, with or without explanation.

4. Author Warranties and Guarantees

- **Copyright and originality:** By submitting a manuscript for publication, the author warrants and guarantees that:
 - a) They are the original copyright holder of the work or have obtained all necessary permissions from copyright holders;
 - b) They possess all legal rights necessary to authorise publication of the work;
 - c) The manuscript is original and does not infringe any third party's copyright, intellectual property rights, or any other rights;
 - d) The manuscript has not been published elsewhere in substantially the same form and is not under consideration for publication elsewhere.
- **Plagiarism:** The author warrants that the manuscript does not contain plagiarised material and that all sources have been properly acknowledged and cited in accordance with academic standards.
- **AI usage:** Manuscripts wholly, substantially, or substantively generated by AI, machine learning, or similar tools will not be published in Lexxion journals. Authors are permitted to use AI for translation, language smoothing, or to aid in research, but must acknowledge this in a footnote. AI cannot be listed as an author or co-author.

It is the author's responsibility to verify the accuracy and integrity of *all text, visualisations, references and information* generated or obtained through the use of AI tools.

Manuscripts containing fictitious, hallucinated, incorrect, or non-existent citations will be rejected. In cases of serious or repeated violations, or where deliberate misconduct is established, the journal reserves the right to impose additional sanctions, including restrictions on future submissions.

- **Content standards:** The author warrants that the manuscript does not contain any defamatory, discriminatory, racist, or otherwise illegal content, and that it complies with all applicable laws and regulations.
- **Accuracy:** While Lexxion Publisher takes reasonable steps to ensure quality, the author remains solely responsible for the accuracy, completeness, and integrity of the content of their manuscript.
- **Conflict of interest:** The author shall disclose in a footnote any conflict of interest that may be relevant to the work.

5. Disclaimer and Limitation of Liability

- Lexxion Publisher shall not be held liable for the content, accuracy, or integrity of any material submitted and published. All views expressed in published articles are those of the authors and do not necessarily reflect the views of Lexxion Publisher.
- Lexxion Publisher shall not be held responsible for any errors, omissions, or inaccuracies in published content.
- Upon receiving notification of a potential legal violation (including but not limited to copyright infringement, defamation, or breach of privacy) and having satisfied itself of the legitimacy of such notification, Lexxion Publisher will remove the offending content and may pursue appropriate remedies.

6. Copyright Transfer and Grant of Rights (Standard Publication)

- By submitting a manuscript for publication under the standard publication policy, the author:
 - a) Transfers all copyright in the work to Lexxion Publisher;
 - b) Grants Lexxion Publisher an exclusive, perpetual, irrevocable, royalty-free, worldwide licence to publish, reproduce, distribute, display, and make available the work in any format and through any medium, whether now known or hereafter developed, including without limitation:
 - i. Print publication in the journal to which it was submitted;
 - ii. Electronic publication on Lexxion Publisher's websites, databases, and platforms;
 - iii. Publication in other Lexxion publications, compilations, or derivative works;
 - iv. Distribution through third-party aggregators, indexing services, and databases;
 - v. Promotion and marketing through Lexxion Publisher's media and social media channels;
 - vi. For the training, development, and improvement of artificial intelligence and machine learning systems.
- The author shall be credited as the author of the work in all publications and uses by Lexxion Publisher.
- Following copyright transfer, the author may not exercise any of the exclusive rights transferred to Lexxion Publisher without obtaining prior written permission, except as expressly permitted under Clause 10 (Republication and Self-Archiving Rights) below.

7. Open Access Publication Option

- Lexxion Publisher offers authors the option to publish their article under an Open Access (OA) model, subject to the following terms:
 - a) The final published article is made freely accessible to the public immediately upon publication under a Creative Commons licence (or equivalent open licence as determined by Lexxion Publisher);
 - b) Authors retain copyright in their work and are granted broader republication and self-archiving rights as set out in Clause 10 below;

c) Authors, their institutions, or their funding bodies must pay an Open Access fee. The current OA fees, per journal and publication type, are available at:

- **Payment of Open Access fee:**

- a) The Open Access fee must be paid in full before the article is made openly accessible.

- b) Authors are encouraged to check whether their institution or funding body offers financial support to cover Open Access fees, as many institutions maintain central funds or agreements to support Open Access publication.

- c) The fee shall be payable upon receipt of an invoice issued by Lexxion Publisher. The author shall provide the publisher with the name and address of the person or organisation to whom the invoice should be addressed and, where applicable, the corresponding VAT number.

- All manuscripts submitted under the Open Access policy must successfully pass peer review in accordance with the journal's Author Guidelines. If a manuscript does not pass peer review and is rejected, no Open Access fee is payable.

- Authors may elect to publish under the Open Access policy at the following points:

- a) Initial manuscript submission; or

- b) Any time following acceptance for publication; or

- c) Any time after the article's publication under the standard publication policy (retrospective Open Access conversion).

- **No fees are applied under the standard (non-Open Access) publication policy.**

8. Archiving and Preservation

- Lexxion Publisher maintains secure electronic backups and archives of all past issues of its journals dating from 2002 onwards.
- In the event that publication of a journal is discontinued, Lexxion Publisher shall make all reasonable efforts to keep the content available to readers, whether online or by request, in any manner deemed appropriate.
- Lexxion Publisher ceases to be responsible for backups and archives of journals that have been acquired by other entities, except where otherwise agreed in writing with such entities.

9. Digital Object Identifiers (DOIs)

- Papers published in most Lexxion journals¹ are assigned a Digital Object Identifier (DOI) to ensure permanent identification and location of the work.
- Where DOIs have been assigned, authors must ensure that any republication or redistribution of their work (where permitted under these Terms and Conditions) clearly displays the corresponding DOI to maintain proper attribution and enable readers to locate the definitive published version.

¹ The following Lexxion journals do *not* support DOIs: AbfallR – Journal for the Law of the Circular Economy (in German), EFFL – European Food and Feed Law Review, and ICRL – International Chemical Regulatory and Law Review.

10. Republication and Self-Archiving Rights

Standard Publication Policy (Non-Open Access):

- **General prohibition:** Following publication under the standard publication policy, the author may not republish, post, upload, or otherwise make available the published version of the article (including the final typeset PDF or any version incorporating Lexxion Publisher's formatting and layout) on any third-party website, repository, platform, or service (including but not limited to ResearchGate, Academia.edu, SSRN, institutional repositories, personal websites, or any other online location) without the express prior written permission of Lexxion Publisher.
- **Embargo period for republication requests:** Where the work was created by publicly funded research, nine months after the date of first publication, the author may contact the Executive Editor of the respective journal to discuss potential further publication in their institution's repository. Any such republication remains subject to the express prior written approval of Lexxion Publisher and will be granted at Lexxion Publisher's sole discretion.

Permitted self-archiving after nine months: Nine months after the date of first publication, authors may post the accepted manuscript version (the final peer-reviewed manuscript accepted for publication, *not* the published PDF or typeset version) to their institution's repository – where required by institutional policy.

- **Conditions for self-archiving:** Any self-archived version must:
 - a) Include a full citation to the article's first publication in the respective Lexxion journal, including journal name, volume, issue, page numbers, and publication year;
 - b) Clearly display the article's Digital Object Identifier (DOI) with a link to the definitive published version;
 - c) Include a statement such as: 'This is the accepted manuscript version. The definitive published version is available at [DOI link].'
- **Prohibited self-archiving locations:** Self-archiving is **not permitted** on commercial academic networking sites (including but not limited to ResearchGate, Academia.edu), subject-specific repositories (other than institutional repositories), or any platform where the author does not have direct control over access and attribution.

Open Access Publication Policy:

- Authors who publish under the Open Access policy (Clause 7) retain broader republication and self-archiving rights as specified in the applicable Creative Commons licence or equivalent open licence. Such authors may generally:
 - a) Post the published version of their article to personal or institutional websites, repositories, and other platforms immediately upon publication;
 - b) Republish their article in other works, subject to proper attribution and compliance with the terms of the applicable open licence.
- All republications (whether under standard or Open Access policies) must maintain academic integrity, provide full attribution to the original source, and comply with all applicable laws and ethical standards.

11. Breach and Enforcement

- Lexxion Publisher reserves the right to take appropriate action in response to any breach of these Terms and Conditions, including but not limited to:
 - a) Requesting immediate removal of improperly posted or distributed content;
 - b) Withdrawing an article from publication;
 - c) Refusing to consider future submissions from the author;
 - d) Pursuing legal remedies for damages.
- German law applies to interpretation and enforcement of the Terms and Conditions.

12. Modification of Terms

- Lexxion Publisher reserves the right to modify these Terms and Conditions at any time. Authors will be bound by the version of the Terms and Conditions in effect at the time of manuscript submission.
- Material changes to the Terms and Conditions will be communicated to authors via the journal websites and other appropriate channels.

13. Acceptance of Terms

- **By submitting a manuscript to any Lexxion journal, the author acknowledges that they have read, understood, and agree to be bound by these Terms and Conditions in their entirety.**
